La Academia Dolores Huerta Charter Middle School

I. POLICY:

La Academia Dolores Huerta (LADH) is committed to ensuring that homeless students have equal access to the same free, appropriate public education and services, provided to other students in accordance with the provisions of the McKinney-Vento Homeless Education Act, 42 U.S.C. § 11431 et seq. LADH recognizes that for all students to be successful they must be provided with school stability and academic supports.

Students who qualify for this program include "Children and youth who lack a fixed, regular, and adequate nighttime residence." This includes children/youth who are:

- sharing the housing of other people due to loss of housing or economic hardships (e.g., "doubling-up")
- living in motels, hotels, RV parks, or camping grounds due to lack of alternative accommodations
- living in emergency or transitional shelters
- living in public or private places not designed for or ordinarily used as sleeping dwellings for humans
- living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings
- migratory and live in one of the above circumstances
- abandoned in hospitals or designated safe havens

The McKinney Vento Homeless Assistance Act provides certain rights and protections. Students experiencing homelessness have the right to:

- Free and appropriate public education
- Receive educational services comparable to those provided to other students
- Immediately be enrolled in a local school or continue attending the school of origin (e.g., the school they attended when permanently housed or the school when they were last enrolled), whichever serves the student's best interest.
- Immediately enroll in the local school even if required enrollment documents are unavailable (e.g., previous academic records, immunization records, health records, proof of residency, proof of guardianship, and/or proof of age) and application/enrollment deadline was missed.
- Received transportation to and from school if requested

LADH will designate a local education agency (LEA) homeless liaison who will ensure:

- Homeless students are identified by school personnel and/or through coordination with other school districts and community agencies
- Homeless students are enrolled and have equal access to all opportunities to succeed in school
- All eligible members of homeless families receive education services (e.g., Head Start) and are referred to health care, dental care, and mental health services when needed
- Parents/guardians of homeless students are informed of opportunities to participate in their student's education
- Dissemination of information on the education of homeless children/youth

- Provide parents/guardians information about transportation services to and from school
- Mediation of enrollment disputes

II. PROCEDURE:

- 1.) At time of registration, parents/guardians will complete the homeless survey as part of their registration packet.
- 2.) LADH secretary/registrar and/or homeless liaison will review enrollment packets and identify homeless students
 - a. If an identified homeless student does not have required LADH enrollment documents, they will be immediately enrolled, and the secretary will then work with the parent/guardian to obtain academic and other records from the last school attended by the student.
 - b. If at the time of enrollment LADH has no available slots, LADH will assist the student with finding another school within the area where the family is staying.
- 3.) To ensure that all previously identified homeless students are included on the homeless student registry, LADH secretary/registrar and/or homeless liaison will review all incoming and transfer students' cumulative files when received.
- 4.) LADH secretary/registrar, in coordination with LADH homeless liaison, will maintain and update, as needed, the homeless student registry.
- 5.) LADH secretary/registrar will provide the homeless student registry to the LADH homeless liaison for review and follow-up with families.
- 6.) If a dispute arises over enrollment at LADH, the parent, guardian or unaccompanied student shall be referred to the school's liaison, who will immediately initiate the dispute resolution process after receiving notice of a dispute. [42 U.S.C. § 11432(g)(3)(E)(iii)].
